## How to Book LTC 80 Fare Tickets?

### LTC 80 Fare Tickets: Booking Options and Steps

The booking options and steps for LTC 80 fare tickets are as follows:

- The booking can be made either on the Air India website or through their authorized travel partners.
- While entering the arrival and departure destinations, select the Leave Travel Concession (LTC) fare option.
- Choose the preferred flight option and continue.
- Enter the details of the passengers travelling.

- Enter the details of your government ID card that will be required for verification at the time of check-in.
- Proceed for payment after confirming the booking details.

## **LTC 80 Fare Tickets: Documents and Verification**

The documents and verification required for LTC 80 fare tickets are as follows:

- A valid government ID card is mandatory for all passengers travelling under LTC 80 fare scheme. The ID card should have the same name as mentioned in the booking.
- The family members of the government employee should carry a copy of the same ID card along with a proof of their relationship such as marriage certificate, birth certificate, etc.
- The government employee should also carry a copy of his/her official order or sanction letter that authorizes him/her to avail LTC.
- The passengers should present their ID card and other documents at the time of check-in for verification by Air India staff.
